Includes 194 previously unreported stock units that have been credited as dividend equivalents under the deferral feature of the 2003 Plan.
- The reporting person also holds 4,172 stock units under the Company's Director Phantom Stock Plan, which units are convertible for an equal number of shares of The Macerich Company's common stock.
