Explanation of Responses:

The issuer elected to redeem the reporting person's Units with common stock. The reporting person also holds 45,553 vested LTIP Units and 8,527 unvested service-based LTIP Units.
- The reporting person also holds 161 shares in a trust for the benefit of one of his children.
- In addition, 50 shares are held by his adult child who is currently sharing the reporting person's household. The reporting person disclaims beneficial ownership of all shares held by this child, and this report should not be deemed an admission that the reporting person is the beneficial owner of such shares for purposes of Section 16 or otherwise.
